

## Membership Information & Initiation Fee Guidelines

\* Any former member who resigns from the club and subsequently wishes to rejoin after a period of 1-year, will pay 1/2 of the CURRENT applicable initiation fee at the time of rejoining. Any former member who wishes to rejoin within one year of resigning his/her club membership will be responsible to pay 1/2 the CURRENT applicable initiation fee AND all applicable back dues and assessments from the time of resignation.

\* Any member who wishes to downgrade their membership, i.e. from Resident to Social, then subsequently wishes to upgrade again from Social to Resident, will be responsible for 1/2 the CURRENT applicable initiation fee. If upgrading occurs less than one year from the initial downgrade, the member will be responsible for 1/2 the CURRENT applicable initiation fee AND all applicable back dues and assessments from the time of the membership downgrade.

\* Children of a Resident Member that are under the age of 35, may join without payment of initiation fees.

\* Changing from Junior to Young Adult, from Young Adult to Young Resident member or from Young Resident to Resident member because of a birthday, will not require payment of additional initiation fees.

\* Non-Resident, Clergy and Social members wishing to upgrade, are responsible to pay the difference between the initiation fee when joining and the initiation fee in effect for the selected membership at the time of the membership upgrade.

\*If a Resident Single, Young Adult Single or Junior Single member marries, there will be no additional initiation fee charged but the membership class will be changed to either Resident Family, Young Adult Family or Junior Family. Appropriate food minimums will be implemented.

\*Resident Single, Young Adult Single and Junior Single memberships are available to only those individuals that are not married.
